We all started out with a common goal in mind: to get outside and have fun in the snow, and to help other people learn how to do the same. With this in mind, the following policy has been adopted by the CADS Calgary Adaptive Ski/Snowboard School so that we can all continue to go outside and have fun in the snow for many more years!

Please read carefully:

As a participant in the CADS Calgary Adaptive Ski/Snowboard School, I understand and agree to the policies stated below:

A.) We understand and recognize that the CADS Calgary Adaptive Ski/Snowboard School is volunteer staffed and administered and as such realize that there are situations that may arise that are beyond our volunteers' control. With this in mind, the Calgary Adaptive Ski/Snowboard School wishes to remind everyone that we are all here for the same reason – **TO SKI AND HAVE FUN** – if there is a problem which you feel needs to be addressed, please bring it to the attention of the following:

- 1.) Your Program Supervisor
- 2.) Ski/Snowboard School Directors: Laura Lee Crook & Tony Crook
- 3.) CADS Calgary Administrator: Marueen O'Hara-Leman
- 4.) Calgary Board Chair: Thomas Griffith

All attempts will be made to deal with issues in a timely manner.

B.) If I am going to be absent from a Sunday evening lesson, I will contact my program supervisor by **5:00 pm Sunday** (earlier would be better but we understand things happen) by:

- 1.) Calling/emailing your Supervisor directly (Supervisors will supply contact information and let you know the best way to get hold of them).
- 2.) Leaving a message on the CADS Ski/Snowboard School Office Phone 403-286-8050. Please note: messages are not checked after 6:00 pm.
- 3.) Sending an email to info@cadscalgary.ca by 5:00 pm on the lesson day.

C.) I understand that if I/we arrive later than 6:45 pm, without the prior knowledge of the program supervisor, my volunteer may be released and reassigned where needed. If when I arrive there is not a volunteer available to provide instruction, I understand and accept that there will not be a lesson that evening.

D.) I understand that the CADS Ski/Snowboard School does not have control over volunteer attendance and as such, if the need arises for my child to work with a

variety of volunteers during the lessons, it is not something that is done as a result of poor planning on the part of the ski/snowboard school or the supervisors. I will do my best to work with the program supervisor for my son or daughter to have an enjoyable experience during the course of the program.

- E.) Should my child require assistance in using the washroom, I/we or a support worker will be present at COP on ALL lesson nights for the duration of the lesson. I acknowledge that CADS volunteers **ARE NOT PERMITTED TO ASSIST ANY STUDENTS WITH USING THE WASHROOM FACILITIES.**
- F.) Should my child require my intervention to prevent behaviour issues I/we or a support worker will be at COP on **ALL** lesson nights for the duration of the lesson should such assistance be required.
